The Foundation for Accountability and Civic Trust is a conservative front group that regularly files frivolous, partisan ethics complaints against Democrats. Their accusation is without merit.

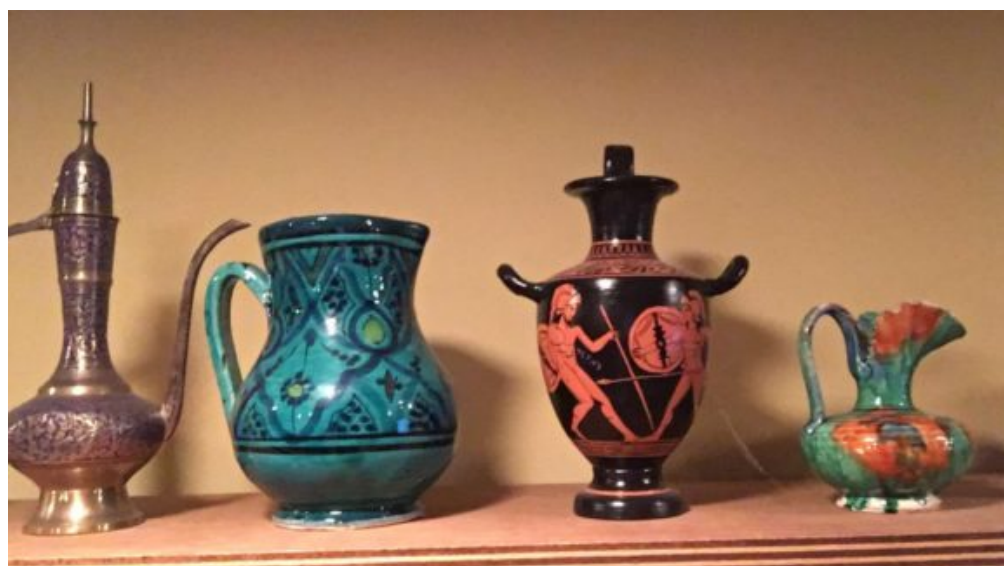
